2018 Corporate Equality Index



For the second year in a row, Ogletree Deakins is delighted to have earned a perfect score of

100 percent on the 2018 Corporate Equality Index (CEI), a national benchmarking survey and report on corporate policies and practices related to lesbian, gay, bisexual, transgender, and queer (LGBTQ) workplace equality, administered by the Human Rights Campaign Foundation. In the 2018 edition of the CEI, 947 of the nation's largest businesses validated their dedication to LGBTQ equality and inclusion. As a result of this dedication, a record-breaking 609 employers earned a perfect 100 percent score. The CEI report evaluates LGBTQ-related policies and practices including non-discrimination workplace protections, domestic partner benefits, transgender-inclusive healthcare benefits, competency programs and public engagement with the LGBTQ community. Ogletree Deakins received the most mentions of any law firm in the 2017 edition of <u>Corporate</u> <u>Counsel magazine's</u> "Who Represents America's Biggest Companies" survey and also received the most mentions of any firm in the Labor and Employment Litigation category.
